4. Presentation of Annual Report by the President

Welcome to everyone and thank you for embracing the presentation of our AGM via zoom. We introduced the new format for the annual report at last year's AGM.

2020 was a very challenging year for the association. We finished the year in a relatively strong position thanks to the government stimulus package, we received Job Keeper for six months, various tax incentives and a credit from Western Power.

Thanks to the Board and Finance committee for ensuring that expenditure was carefully monitored over the year.

Comment: The Annual Report format and presentation is excellent. Acknowledgement to the MAWA staff and all contributors to the annual report.

5. Treasurer's Report

Interest is down in 2020 due to the state of the economy. The Job Keeper and stimulus payments are clearly shown as a separate line item. Costs associated with staff are greater than previous year due to an increase in staff numbers. Administration expenses are down due to carefully management by the office staff.

The overall surplus is \$49 466.

Inventory has been reduced due to the clearing of older stock. \$100K was invested in a BT Panorama. This account type and investments were chosen after the substantial research AAMT did to invest a \$4 million bequest. The set-up cost was \$550. The investment is showing about 2% return in the first quarter of 2021.

Question – Has MAWA had financial advice about what to do with the nearly \$1 million cash. MAWA with the assistance of a financial advisor from Perpetual have created an Investment Policy Statement. This document was considered extensively by the finance and executive committee before being presented to the board. The board endorsed the process that was undertaken to establish this policy. The advice was to have a account that money is on call. This is the CUA account as shown on the financial documentation.

Question – Did MAWA pay for the financial advice. No, we were not charge for the financial advice.

Income in advance is the monies received in 2020 for WAMPSP that is then used in 2021 to pay the teachers who conduct the classes.

Question – Value of the land and building has not changed. Is the building insured for more than this? The building is valued at more than the \$192K stated on the balance sheet.

Actions:

Executive Officer to obtain information on insured value and report to the finance committee and then the board.

Executive Office to determine the impact for the finances of the Association and implication to the ATO if the value of the land and building is increased market value with the auditors.

Members would like the board to consider having the building valued and understand that there is a cost of approximately \$1000 to have this done.
